## Improvements Coming to Mill Creek Park!

## Our New Building

Staff is finally settled into our new Administrative Office Building. The 6,138 sq ft building was completed and furnished in January 2023, **without** needing to obtain a loan or increase taxes. Careful budgeting, township growth, and ARPA funds (stimulus money) made this possible.



Many upgrades were implemented, and more will be in the future. We can now upload plans and agendas to the large screen TVs during meetings. Our new website was designed to be user friendly. We are always exploring other options for keep our residents better informed.



UPDATE on the future headquarters of Northern York County Regional Police Department. Groundbreaking took place on April 27, 2024. The facility is located at One Regional Way, which is on the corner of Susquehanna Trail North and Regional Way. The building is part of the Manchester Township commerce Center. Northpoint Developers generously donated the 11+ acre lot to the police department to build the new state of the art building. The drone picture above shows the cement pad has been completed and the walls are going up. Hopefully, it will be under roof by the end of the year. Weather pending, it will be completed by May, 2025. A "thank you" to Brian Kimball for documenting the construction through drone footage and photographs. He is volunteering his time and skills to the department. A ribbon cutting and open house is being scheduled when completed. It will be announced on NYCRPD and Conewago Township's websites and on the SAVVY Citizen App.

Our current hours are Monday-Friday, 8am-2pm. The membership is free, but registration requires proof of identification (driver's license, PA ID card, birth certificate) as seniors must show that they are over 60 and a resident of York County. If over 65 years of age, we will forward you applications for both the Area Agency on Aging and Rabbit Transit. Rabbit provides curb to curb service for seniors to attend the center, go on trips, or for personal use. The fees are calculated by mile, but to attend the center is free!

If you are over 60 years of age and become homebound you can call the York County Area Agency on Aging (YCAAA) @ 717-771-9610 to receive Home-Delivered Meals if eligible. Our center recruits volunteers from the local community to deliver in 10 municipalities covering 125 square miles, although we must have the paperwork from YCAAA prior to meal deliveries. If you'd like to volunteer to deliver you would need 3-3 1/2 hours of time and be available Monday mornings 8:30am-11:30am. Driver's license, insurance, registration & background checks are necessary to volunteer.

Our building we purchased in September of 2023 has had many setbacks and we do hope to relocate there in the summer of 2025!

**WE NEED YOU!** Strinestown Community Fire Company is strictly a volunteer fire company. In a year, we average between 300 and 400 emergency calls. Strinestown Community Fire Company is the sole provider for Conewago township. Every firefighter volunteers their time to help you in a time of crisis or in the time of need. There are two types of Members. An Operational Member is for someone who is 18 years or older that is interested in participating in fire/rescue calls. Experience is not necessary and free training is offered. A social member is for an adult that is not interested in responding to fire/ rescue calls.

**Reminder!** Make sure smoke detectors are working, are tested, and the batteries are changed every year. This is your first defense of being hurt or killed. Smoke detectors should be on every floor and outside every bedroom. Fire extinguishers should be placed in the kitchen, garage, and near the furnace. There are many different types of extinguishers. When purchasing an extinguisher make sure that it meets the most common fires found in a home.

Conewago Township has a contract with the SPCA of York County to provide services to our residents.

**Below is a list of provided services.**

- Yearly and Lifetime Dog licensing, microchip and rabies vaccination clinics.
  - Animal Related Municipal Ordinance consultation.
- Full record keeping and documentation required by the Department of Agriculture's Bureau of Dog Law Enforcement.
- Low-cost spay/neuter assistance including programs for outdoor stray cat colonies and discounted spay/neuter for all pit bulls.
  - Humane investigations, citations and prosecutions of animal cruelty and neglect.
  - Veterinary care for sick and injured animals through SPCA Second Chance Program.
- Temporary foster and veterinary care for pets of domestic violence in conjunction with YWCA Hanover's Safe Home, YWCA York's Safe Home, the Red Cross, Bell, YMCA Men's Shelter and Life Path.
  - Humane education programs for York County youth through elementary and secondary educational institutions.
    - Pet food for elderly residents living on a fixed income or for financially disadvantaged residents through SPCA Pet Food Pantry Program.

## WHEN AND WHAT PERMITS ARE REQUIRED

From time to time residents ask when do I need a permit or when is a permit required.

Many don't realize that there are various permits required for different projects.

### BUILDING / UCC PERMITS

A building permit is required for all construction projects, residential, commercial, industrial and agricultural. The application should be submitted 30 days prior to actual construction. All construction projects must meet the 2018 International Residential Code for residential use and the 2018 International Building Code for commercial and industrial uses. To determine if your project is applicable call the township office .

### POOL PERMITS

All residential in-ground and above-ground pools capable of holding 24 inches or more of water, require a permit, whether temporary or permanent. All pools with sides less than 48 inches high require a fence of 48 inches high. All Spas/Hot tubs require permits.

### STORMWATER PERMITS

All new impervious surfaces created must address stormwater i.e. sheds, garages, sidewalks, patios and pavilions. Gravel is considered impervious.

### ON-LOT SEWAGE PERMITS

Sewage Permits are required for all new and repairs to existing on-lot systems.

### DRIVEWAY PERMITS

Permits are necessary for all new driveways. The repaving, repairing or improving of an established existing driveway require permits & Stormwater Management needs to be addressed.

### AUTOMATIC ALARM PERMITS





Permits are required for automatic alarms that emit a sound or transmit a signal or message when activated.

*This only lists a few of the more common permits that are required. Each property owner is responsible to obtain the necessary permits prior to the start of construction. Normal hours for permits are Monday thru Thursday 7am-5pm. Please call before you stop by for permits as the Building Permit Officer may be out on inspections or code enforcement issues.*

MULCHING LEAVES ISN'T A **TRICK...**  
IT'S A **TREAT** FOR YOUR LAWN!

**Fall leaves and other organic plant material  
are storm water pollutants!**

-  Leaves and yard debris left in the street contribute nutrients to storm water runoff that cause serious water quality issues!
-  Mulch leaves with a lawn mower. Leaves provide nutrients for healthy soil, Mother Nature's fertilizer.
-  Keep storm drains clear of leaves. Make sure your lawn care service is properly disposing of all waste.
-  Penn Waste provides **Curbside Collection of Yard Waste** in the fall. Leaves must be placed in biodegradable brown paper bags and placed curbside for pickup **only** on the days listed for yard waste on the **Penn Waste Schedule**.



**DON'T** blow or place leaves and yard debris on the sidewalk, or storm drains!

**DO** compost your leaves or bag them for Penn Waste recycling!

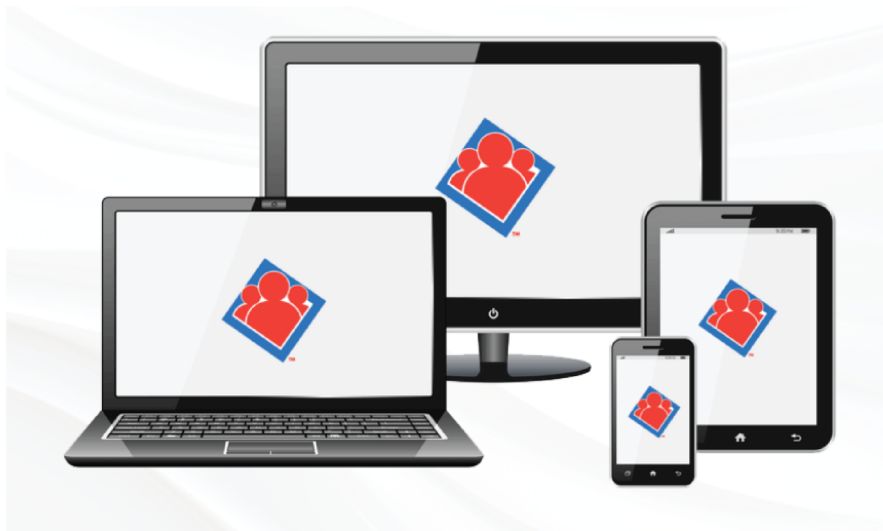

# Storm Water Management

## Here's What You Can Do

### Research ways to reduce stormwater runoff from your property.

Projects like rain barrels and rain gardens are just some examples of ways you can help reduce the amount of stormwater runoff from roofs and driveways. For more ideas, visit [www.watershedsyork.org](http://www.watershedsyork.org).

### Check your local Stormwater Management Ordinance when making changes to your property.

Every municipality in York County has rules for dealing with stormwater. Your municipality can help you understand the requirements. You can also use the York County Integrated Water Resources Plan Flowchart Tool, at [www.PAIWRP.com](http://www.PAIWRP.com).

### Report illicit discharges.

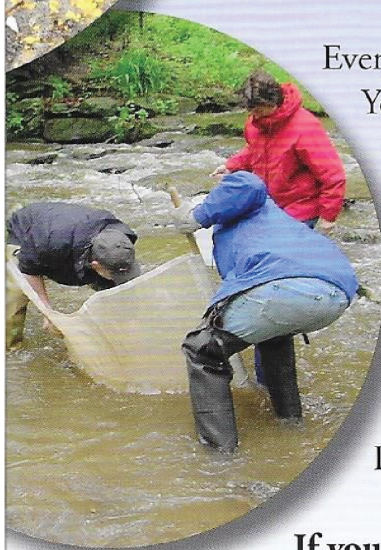
If you see water or another substance being discharged from a pipe or opening, and suspect it is illegal, contact your local municipality or the Pennsylvania Department of Environmental Protection.

### If you have a septic system - maintain it properly.

Malfunctioning septic systems are a major source of nutrients being improperly released to local streams. Even if you can't see a problem, a poorly maintained or neglected septic system can be contributing to pollution in nearby streams. Contact your local municipality for guidance.

### Report flooding problems to your local municipality.

Flooding from excessive stormwater is a sign that a stormwater system may not be functioning properly. In addition, surging water picks up sediment and nutrients and quickly sweeps it into nearby streams and creeks.



# Conewago Stormwater Management Ordinance #344

Effective November 6th, 2023

## What is Stormwater?

Stormwater is precipitation that runs off impervious surfaces, such as rooftops, paved areas, or stone, and runs into stormdrains, sewage systems, or directly into lakes and rivers.

## Why is managing Stormwater important?

Stormwater runoff picks up contaminants, such as chemicals, bacteria, or debris from every surface it crosses, and because it does not infiltrate into the soil, it is not filtered prior to entering surface, or ground waters. This contamination can lead to toxic algae blooms, bacterial or nitrogen overload, low-oxygen dead zones, and other negative impacts to local waters.

## How does managing Stormwater help?

Stormwater management aims to capture water at the site and allow it to infiltrate into the soil and be filtered before it ultimately replenishes ground water aquifers or local waterways.

## Who is responsible for managing Stormwater?

The property owner is responsible for controlling stormwater runoff on their property. Conewago Township directs stormwater management on the Municipal level by enforcing our Stormwater Management Ordinance through permitting and outreach. This requirement is a mandate from the United States Environmental Protection Agency (EPA), Pennsylvania Department of Environmental Protection (DEP), and York County. Failure to comply with these mandates would subject Conewago Township as a whole to penalties from DEP, EPA, or both.

## What property owners should know.

The creation of any new impervious surface requires the submission of a Stormwater application to control Stormwater runoff. Please note that gravel is considered an impervious surface. We have worked with our Township Engineer to create a Small Projects Management Guide to assist property owners in finding inexpensive solutions to stormwater management on projects under 2500 square feet.

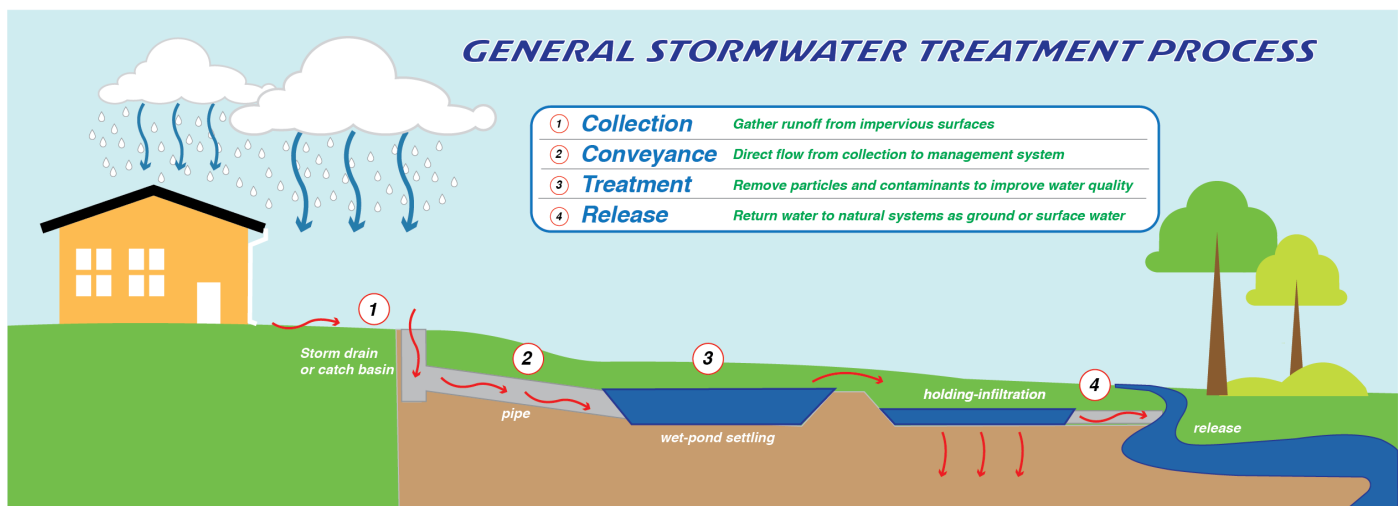

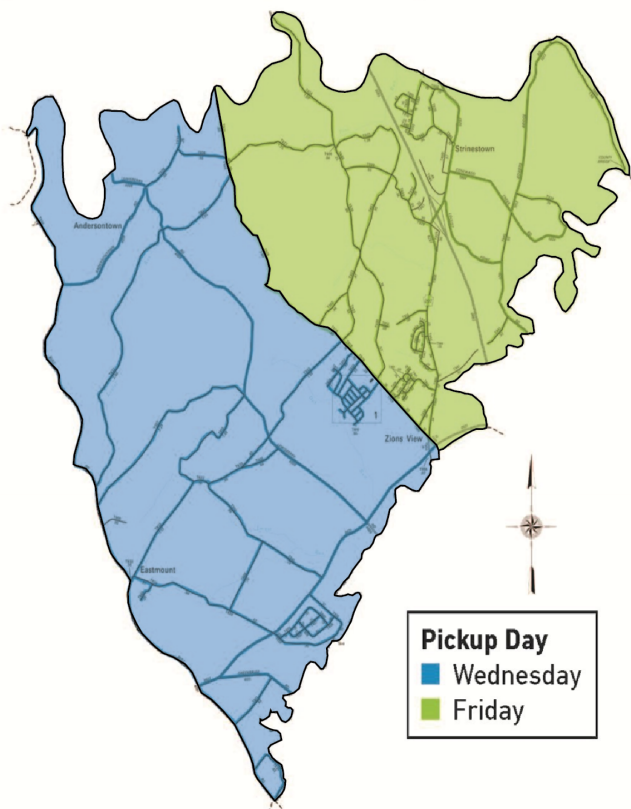

**Collection Guidelines**

Yard waste is...  
 material such as tree trimmings, shrubbery and other organic landscape vegetation not listed below.



- How to Prepare Yard Waste**
- Place yard waste in biodegradable brown paper bags or bundle it with biodegradable twine in easy-to-handle bundles.
    - Bundles may be no longer than 5 feet in length.
    - Bundles may not weigh more than 30 pounds each.
    - Bundles may not exceed 6 inches in diameter.
  - Once prepared, yard waste must be placed at the curb on scheduled pick up day before 6:30 am.
  - An unlimited number of bags or bundles may be placed at the curb.

**DO NOT place these items out for yard waste collection:**
