-Call to Order & Pledge of Allegiance:

The regular meeting of the Board of Supervisors was held at 490 Copenhaffer Rd. York, PA 17404. The meeting was called to order by the Chairperson Wilhide at 6:00pm. Those in attendance were Lorreta Wilhide (Chairperson), Brian Klinger (Supervisor), John MacDonald (Supervisor), Derek Rinaldo (Engineer, Lieutenant Neidigh (NYCRPD), Josh Kopp (PWD/Manager), Shanna Housman (Office Administrator), Bethany Inman (Zoning Officer).

Executive session took place before meeting, regarding legal matters.

-Public Requests:

Todd Miller, Dylan Dr. shared concerns about Penn Waste and wanted some updates from the meeting.

-Approval of Agenda: Motion by Supervisor Klinger, second by Supervisor MacDonald, unanimously carried to approve the agenda. Vote: 3-0

-Approval of Previous Minutes: Motion by Supervisor MacDonald, second by Supervisor Klinger, unanimously carried to approve the March 2025 minutes. Vote: 3-0

-Planning & Zoning:

-Friel Subdivision: Tony Cross presented this subdivision; they are taking .4 acres from 90 acres and are adding it to a 1.5-acre lot. Planning recommended to move forward. Motion by Supervisor MacDonald, second by Supervisor Klinger, unanimously carried to approve the Friel Subdivision. Vote: 3-0

-Other Business:

-Supervisor Klinger had a meeting with Chief Hoff from YAUFR about paid firefighters. For 2 guys 24/7, it would be 1.8 million a year. He would like it if the Township would consider donating annually.

-Josh and Shanna are scheduling a meeting with Chief Hoff from YAUFR about an EMA Coordinator.
