## **NEW BUSINESS:**

- -Donald and Peggy Knouse waiver request. Represented by Mr. Dave Hoffman -Sec. 505.C-Requesting to pay a fee in lieu of road widening. A motion was made by Hull, second by Mr. Appel, unanimously carried.
- -Donald and Peggy Knouse Final Subdivision Plan. A motion was made by Mr. Appel to grant the Final Subdivision Plan, second by Mr. McCoy and unanimously carried.
- -Zambito/Bennett Run waiver requests. Represented by Mr. Rick Fink with Kinsley. Mr. Zambito excused himself.
- -Section 514.b-Water Supply requirements. Mr. Appel made a motion to approve the waiver request, second by Mr. Hull, unanimously carried.
- -Zambito/Bennett Run Final Subdivision Plan. Mr. Zambito excused himself. Mr. Hull made a motion to approve the plans conditioned upon remarks or comments stated in Mr. Shue's comment letter. Second by Mr. Appel, motion carried.
