The regular meeting of the Board of Supervisors was held at the Township Municipal Building. The meeting was called to order by the Chairman, at 7:00 P. M. ## -Pledge of Allegiance:

## -Recognition of Public Requests:

- Jane Deamer of the Northeastern Senior Community Center- Presented an attached break down of the monthly attendance and meals delivered in the past year for the municipalities served. She thanked the township for their support.

- Scott Wagner of Penn Waste and Neil Slenker of Stock & Leader- presented an amendment to the current trash collection ordinance asking that the township to assist in collecting overdue and delinquent accounts and legal fees. Motion by Mr. Hahn 2<sup>nd</sup> by Ms. Wilhide motion carried to authorize Timothy Bupp draft an amendment to the existing ordinance to allow Penn Waste to collect legal, delinquent and overdue fees at the magistrate's office.

- Jake Perry of 460 Old Stone Way-Truck traffic on trail from ES3 LLC staging in the turn lane making it very difficult coming north on the trail to make a left turn onto Fieldstone.

Mr. Nade of 385 Jug Rd. - asked what is going to be done with the pipe crossing at 385 Jug Rd. Mr. Myers said we are looking into different options for the repair.

Mr. Keeports of 2670 Mill Creek Rd. - questioned the R.O.W. of Canal Rd. and the talk of a traffic light that might be installed at the intersection of Mill Creek and Canal Rd.

Mr. Dunkin of 980 Jug Rd. - who designed the intersection of Mill Creek and Canal Rd. **Unfinished Business:** 

-Bennett Run no parking signs- Mr. Hahn reviewed the process of how the No Parking signs came to being. Mr. Hahn motioned to rescind the No Parking Ordinance having all signs removed  $2^{nd}$  by Ms. Leonard. Ms. Wilhide asked for an executive session to discuss legal matter before voting. Many residents of Bennett Run Development voiced there concerns with the No Parking signs. Mr. Knouse of 805 Copenhaffer Rd. noted that the township has no authority to enforce the home owner's rules and regulations. After discussion Mr. Hahn and Ms. Leonard yea, Ms. Wilhide nea, Motion carried.

-Cross Farm Lane Truck Traffic- No action was taken.

-Approval for Big Conewago Ave. Pavement Reconstruction CDBG project- Mr. Hahn Motion that we except the contract  $2^{nd}$  by Ms. Wilhide motion carried.

#### -New Business:

- Policy to confirm that when an employee turns 65 and is no longer allowed to stay on the Capital Blue Cross group health plan, the township will reimburse the full time employee for their Medicare and supplement plans. Ms. Leonard motioned to approve 2<sup>nd</sup> by Ms. Wilhide Motion carried.

-Zoning Ordinance Amendment proposed by Morris & Richie Associates on behalf of Lennar Homes- Josh Georg presented information stating that the number of homes proposed would not be any more than already allowed by special exception for S668 Single Family Attached Dwellings. Not asking for more units just different configuration. Mr. Hahn motioned not to take action on the proposal 2<sup>nd</sup> by Ms. Leonard motion carried.
